

EVEN START

The Community Foundation is skilled at bringing together needs, services, and resources to deliver specific results. By facilitating a connection between Cornell's Kappa Kappa Gamma sorority and TST-BOCES, a designated gift of \$25,000 generated a grant to preserve the Even Start program in Newfield and Groton.

For the past 16 years, TST-BOCES Even Start Family Literacy Program has provided an integrated program of early child-hood and parenting education to low income, low literacy families in our rural communities. The program helps to break the cycle of poverty and illiteracy by guiding adults to set goals and obtain education and employment, at the same time as they take on the crucial role of becoming their own children's




first teachers. TST-BOCES Even Start has consistently met or exceeded New York State performance indicator targets, but was in danger of having to eliminate sites for the 2009-2010 year if new funding was not secured to replace the loss of New York State funding.

This preservation grant was made after Community Foundation consultation with the leadership of Cornell's Kappa
Kappa Gamma sorority who were seeking opportunities to make a philanthropic investment in the area of literacy and education. By linking Kappa Kappa Gamma's interests with the Community Foundation's Children
and Youth Fund, valuable resources were supplied to preserve a proven program.

The new home at 417 Martin Luther King Jr. Street/W. State Street will lower expenses and open possibilities for a streamlined operation and increased audiences. Access to health care is a long term and very current issue of great concern to many in the United States. Locally a number of Ithacans have developed a nationally renowned model expanding service to those of our neighbors and friends most vulnerable by launching the Ithaca Health Alliance's Free Clinic. Community Foundation grants have assisted in physical plant renovations, expanded pediatric and ob-gyn care, secured equipment, and increased access by supporting diagnostic procedures and provider-malpractice insurance. Grants have been made from the Women's Fund, the Howland Foundation process, and donor advised funds.



LISTENING LEARNING

The Community Foundation, in partnership with AFCU, BOCES, CAP (Community Arts Partnership), HSC (Human Services Coalition), and Sustainable Tompkins embarked on a Listening Learning Tour in 2009. The primary purpose was to open an ongoing line of communication with various nonprofit organizations related to their current economic challenges and future strategic planning.

The Community Foundation had interesting and frank discussions with groups of nonprofits in the arts, environment, education, human services and community building. We heard about frustrations, we heard about possibilities, we heard about dreams but most of all we heard from people who really care about this community.



These needs can be addressed by annual grant making programs to provide funding for local charitable agencies, or by special initiatives in response to specific needs.

With the Legacy Society and the Tompkins Today and Tomorrow Fund, anyone can be a philanthropist. There is no minimum requirement on gifts. Donations can be made in cash, stock, real estate, or through many other types of assets.

Planned gifts may also be directed to a specific **Field of Interest Fund**, such as the **Women's Fund** or the **Social Justice Fund**. And planned gifts may be used to add to or to create a **Donor Advised Fund**, in which the donor or donor's surviving family members may act as advisors in recommending where and when grants are made.

ROSEN LEGACY GIFT

In 2009, Community Foundation received the single largest gift to date in our 10 year history. This gift of more than \$2 million comes from Dr. Bernard Rosen, a member of the Community Foundation's Legacy Society, who made a bequest in his will to



give the bulk of his estate to the Community Foundation. Dr. Rosen, a professor at Cornell University since 1966, emeritus since 1993, died on November 9, 2009, ending a long and distinguished career in sociology. He was preceded in death by his wife Shirley in November 2007. In 2003 and 2004, Dr. and Mrs. Rosen consulted with their legal advisors and created an estate plan which included a philanthropic bequest.

This gift creates the Bernard Carl and Shirley Rosen Library Fund of the Community Foundation which is perpetually dedicated to the importance of the good work of the 33 libraries in the Finger Lakes Library System. It will generate grants totaling approximately \$80,000 to \$100,000 annually in five counties across Central New York.

Dr. Rosen documented his desire for the fund with specific language in his will. "The mission I intend for the Fund is to promote genuine intellectual curiosity and a lifelong love of reading and learning." The specific purpose of the Bernard Carl and Shirley Rosen Library Fund is "to promote greater and easier access by youth to local libraries."

Grants are desired that "allow or encourage teens to visit, study, and read in a library during evening or weekend hours," or "grants to smaller, more rural libraries that enable access to books, reference materials or other resources that might otherwise be unavailable in the community." Grants are not to be "used to replace existing library revenues but to supplement and enhance current resources" nor should the grants "promote a political agenda." Grants are not to be used for "bricks and mortar."

Types of Gifts

The Community Foundation specializes in helping donors develop customized philanthropic action plans for a broad range of assets, using a variety of giving tools.

Please contact us if you would like to explore the many possible ways of structuring a gift for maximum benefit. The Community Foundation of Tompkins County recommends that all charitable giving plans be discussed with your professional advisor.

GIFTS OF CASH We gladly accept gifts of cash, in the form of checks, to support our Tompkins Today and Tomorrow Fund, Field of Interest Funds, or to establish or to grow a Donor Advised Fund.

GIFTS OF SECURITIES Stocks or bonds that are now worth more than when you bought them, or were given them, can also be used to make a gift. In addition to potential income tax deduction benefits, you also may reduce or eliminate capital gains tax on the appreciated value of the securities.

GIFT OF IRA ACCOUNTS OR OTHER RETIREMENT PLANS Simply name the Community Foundation as the beneficiary of your plan. The foundation will not pay income tax, and the gift would qualify for a charitable deduction against any estate tax.

GIFTS OF LIFE INSURANCE You can donate your policy to the Community Foundation and receive an immediate tax deduction (usually an amount equal to the cash surrender value). If you make additional donations sufficient to pay the annual premiums, we can keep the policy in force with eventual benefit to support the work of the Community Foundation.

GIFTS OF REAL ESTATE You can make a gift of real estate and upon sale the net proceeds are available to the Community Foundation. Possible gifts include homes, farms, vacation property, undeveloped land, or commercial property. You also have the option of retaining the right to use the property during your lifetime and giving the remainder value of your home, farm, or other real estate to the Community Foundation. Gifts of real estate may result in significant income, capital gain, and estate tax benefits. Note that gifts of real estate present special issues, and the Foundation board will consider each gift of property of this type on a case-by-case basis.

GIFTS OF CLOSELY-HELD SECURITIES A gift of closely-held securities can be an effective strategy to transfer ownership of your business while resulting in potential tax benefits. Again, given the unique issues involved in closely-held businesses, the Foundation's board of directors will consider each gift of this type on a case-by-case basis.

CHARITABLE BEQUEST You can make a bequest in your will to the Community Foundation for a specific amount, a particular asset, or a remainder interest. The bequest can support the Tompkins Today and Tomorrow Fund, or create or add to a fund for a particular Field of Interest, be designated for specific charities, or be used to create a named fund.

LIFE INCOME GIFTS The Community Foundation offers a variety of vehicles that provide you and other beneficiaries you select with charitable and estate tax deductions and lifetime income. These vehicles include Charitable Remainder Trusts, Charitable Lead Trusts, and Pooled Income Funds. Each offers a unique set of benefits.

TRANSFER A PRIVATE OR FAMILY FOUNDATION A private foundation can become a Supporting Organization; its board can become the advisors that direct disbursements from the fund. If the private foundation board disbands, the Community Foundation's board of directors can continue to administer the fund to support the purposes for which the private or family foundation was formed.

Southern Tier Advocacy & Mitigation Project, Incorporated (S.T.A.M.P.) is an all-volunteer, not-for-profit, Ithaca-based community organization that challenges pollution, criminalization, exploitation, and incarceration.

S.T.A.M.P. achieves success by encouraging self-respect, empowerment, leadership, and self-determination among young people, adults, and families most affected by criminal justice and environmental policies. This unique organization reflects the local values of combining social justice, community organizing, and environmental activism in order to develop critical thinking capabilities in those most underserved by traditional education.

S.T.A.M.P.'s request for its Green Guerillas Youth Media Tech Collective resulted in a grant from an anonymous fund at the Community Foundation. Green Guerrillas study documentary and



narrative filmmaking; make their own media from posters to movies; do outreach at community events; and advocate for equitable living and learning environments. They travel beyond Tompkins County to meet peers and share their work.

Through stories underrepresented in mainstream environmental movements, Green Guerrillas actively assert a rarely heard or respected local voice into the global conversation with confidence in their ability to define themselves and their futures.

Funds Serving You and Your Community

The Community Foundation takes seriously the responsibility and honor to be the steward of resources entrusted to us. Donations which create new funds and grow current funds improve quality of life and solve problems now and in perpetuity.

We are experienced in and committed to prudently invest these funds so that they will always be available for charitable purposes.

Each type of Community Foundation fund may be permanently named for an individual, a family, an organization or a business. Naming a fund creates a lasting tribute to the values and passions of those honored or memorialized.

FUND TYPES

TOMPKINS TODAY AND TOMORROW FUNDS are the most flexible and powerful type of funds enabling the Community Foundation to make initiating and responsive grants to address problems, convene community conversations on emerging needs and build collaborations to solve long standing challenges. These unrestricted gifts support the Community Foundation's role to improve the quality of life in our community in the areas of arts, education, the environment, health and human services and community building.

FIELD OF INTEREST FUNDS include defined areas of interest such as: the Women's Fund, the Social Justice Fund, and for areas such as Children and Youth, Health and Human Services, the Environment, Arts and Culture, and Sustainable Communities.

DONOR ADVISED FUNDS (DAFs) enable donors to establish a fund and to make grant nominations to be considered for charitable giving in Tompkins County and elsewhere for a wide variety of interests. Donors may be individuals/families, nonprofit or for-profit corporations, or an unincorporated group of community members. The beneficiaries of these funds do not need to be identified at the time of fund creation and can change over time to respond to emerging community needs and donor interests.

DESIGNATED FUNDS allow donors to identify and direct the Community Foundation to make their gifts automatically to a specific agency or purpose. Donors can be individuals/families, nonprofit or for-profit corporations, or an unincorporated group of community members. The beneficiaries of these funds do need to be identified at the time of fund creation and remain fixed.

FUND STATUS

Donors may select the status of any fund type to be either ENDOWED or NON-ENDOWED.

ENDOWED FUNDS represent the sustainable and permanent base of support for the Community Foundation in which gifts are reserved to ensure that the Foundation's work thrives in perpetuity.

NON-ENDOWED FUNDS enable donors to actively participate in shorter term grant making.

All funds are assets of the Community Foundation. All grants from any fund are reviewed by staff to ensure legal eligibility and final action is determined by of the Community Foundation Board of Directors. All gifts to the Community Foundation are tax deductible to the extent allowed by law.




