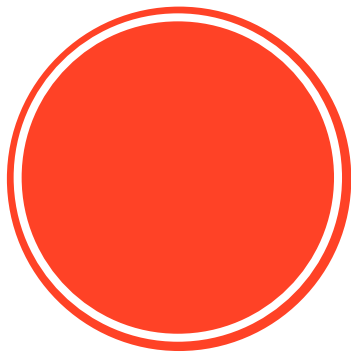

Consider **giving back** to the place which made a difference in your **life**.



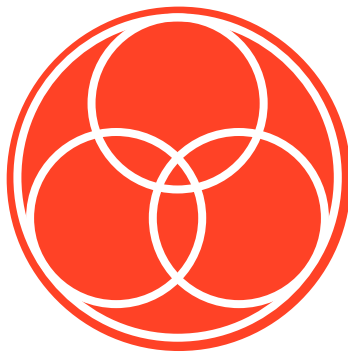
THERE ARE SEVERAL TYPES OF NEEDS COMMUNITY FOUNDATION HELPS YOU ADDRESS

Community Foundation of Tompkins County addresses community needs through collective impact. Please consider:

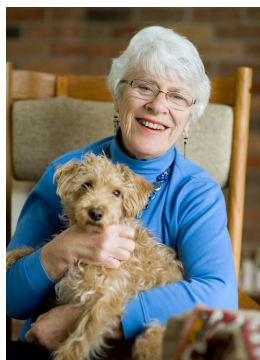
- Including Community Foundation in your will, either a percentage or a specific dollar amount.

- Discussing with your financial advisor how a Charitable Remainder or Charitable Lead Trust can provide income to you or your heirs while also benefiting Community Foundation.
