- Immigration clients in Tompkins County have included the following nationalities: Kenya; Uganda; South Africa; India; Iran; Ukraine; Ireland; United Kingdom; Pakistan; Bangladesh; Canada; Ghana; Nigeria, Russia, Thailand, Mexico, Zambia, USA.
- Examples include:
 - Applying for permanent residence for foreign national immediate relatives (i.e. spouses and parents) of U.S. citizens, including in recent years same sex couples;
 - Assisting a U.S. family who had done an international adoption of an infant. In high school realized they did not have required documentation of U.S. citizenship to apply for financial aid.
 - Assisting immigrants get untangled from abusive marriages without losing immigration benefits.

- Cap-Exempt. Universities and tax-exempt research institutions. No limit on H-1B visas.
